INFORMATION CLAUSE

In connection with the application of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as “GDPR”), which has been applicable since 25 May 2018, we hereby inform you that, pursuant to Article 13 of the GDPR, as of 25 May 2018:

Personal data will be processed for the purpose of reporting on the implementation of the public task – **“INTERCULTURAL MEETING PLACES IN WROCLAW’S LOCAL COMMUNITIES – INTERCULTURAL MEETINGS”**, which is co-financed by the Municipality of Wrocław. The legal basis for the processing of personal data is Article 6(1)(a) of the GDPR (processing is lawful if the data subject has given consent to the processing of his or her personal data for one or more specific purposes).

Recipients of personal data: The data will be entrusted to the Grantor (City Office of Wrocław, ul. G. Zapolskiej 4, 50-032 Wrocław) for the purpose of project promotion and reporting.

Personal data will be stored for 5 years from the date of completion of the Project activities.

The disclosed personal data will not be subject to profiling. The data controllers do not intend to transfer personal data to a third country or an international organisation.

You have the right to access the content of your data and the right to rectify, erase, restrict processing, object to processing, and the right to withdraw consent at any time without affecting the lawfulness of processing based on consent before its withdrawal.

You have the right to lodge a complaint with the supervisory authority if you consider that the processing of personal data violates the provisions of the GDPR.

Providing your child’s personal data is voluntary; however, failure to provide it will prevent the minor from participating in the project activities carried out under the project **“INTERCULTURAL MEETING PLACES IN WROCLAW’S LOCAL COMMUNITIES – INTERCULTURAL MEETINGS”**.
